The above awards were given an extension to their validation following sign-off by DMM FQEC. Senate recommended this amendment be endorsed.

### b) Vice Chancellor's report to Senate (Document SEN10.41)

A debate took place regarding university funding, particularly concerning the fees students would be prepared to pay for courses. It was noted that courses such as business are less costly to deliver than others, such as craft courses, but would potentially lead graduates to earn higher salaries: therefore the rate at which students would be able to pay back the loans would vary even if the course costs were the same.

Concern was expressed over the potential rise in students' expectations of the wider student experience, not just at course level.

# 10.41 Institutional Audit (March 2010): Final Report and University Action Plan (Document SEN10.42)

The final Institutional Audit report from QAA incorporating the University's response was noted.

A plan addressing the QAA's advisable and desirable recommendations for action had been drawn up and considered at the Quality & Enhancement Committee on 17 November 2010, and this was presented to Senate. It was noted that the 'timescale for delivery' column in the Action Plan had not been completed and that more specific responsibility should be identified and assigned in order for each action to be progressed. It was recommended that AQD should take responsibility for completing the timescales in liaison with relevant sub-groups.

# 10.42 New Institutional Review Methodology: summary of the main changes (Document SEN10.43)

Attention was drawn to the following points:

- Reviews will have two components: a core section leading to judgements and a thematic element which will not lead to a judgement
- Judgements to be made on threshold standards of awards, on the quality of students' learning opportunities, on the enhancement of students' learning opportunities, and (from 2012-13) on the quality of public information.
- Recommendations will not be graded but review teams will make clear the approximate timescale in which a recommendation should be addressed
- There will be no briefing visit prior to the review
- A self-evaluation document will be required
- The role of the institutional contact will be enhanced
