2. Programme Summary

The course is aimed at high-calibre candidates over 18-years of age who possess the correct balance of academic ability, analytical and practical skills, and relevant personal qualities such as maturity, resilience and empathy needed to be a professional social worker. Social work in the current context is a challenging yet rewarding profession which operates in an environment where professionals from a range of professions work together with some of the most vulnerable groups in society whether children and families, adults or vulnerable groups. Social workers aim to empower vulnerable people to not only meet their basic needs but to be able to participate fully in the community and society that they belong to. Consequently, this programme is aimed at developing future social workers who have the knowledge, skills and values required to practice in a challenging environment. You will be

helped to appreciate the complexity and uncertainty of the social work profession through classroom teaching and practice learning through placement.

The programme is therefore designed to provide you with a good theoretical basis and the basic skills and values required to practice social work. You are required to undertake 2 placements where your knowledge, skills and values are further developed to help them be adequately prepared to enter the world of social work. The programme is delivered by academic staff, all of whom have vast experience in social work practice, social work practitioners and service users so you have a well-rounded training.

3. Programme Aims and Learning Outcomes

 and cultural context of which social work through a sound knowledge of the theoretical
 foundations that underpin contemporary social work practice which will equip learners to
 deal with complex issues systematically and creatively, in a variety of settings within the
 statutory, voluntary and independent sectors
- Develop in learners the ability to critically evaluate current research and advanced scholarship as well as become critically reflexive practitioners who can undertake independent research and are capable of synthesising information and using this to make sound judgements in the absence of complete data which can then inform professional practice
- 3. Develop in learners the ability to exercise personal initiative and responsibility as well as an ability to identify ethical and value dilemmas in practice and a commitment to uphold the professional standards of conduct, performance and ethics
- 4. Facilitate anti-oppressive practice that works with the inherent strengths of diverse individuals, families, groups and communities along with an understanding of social justice and the capability to challenge injustice
- 5. Produce critically self-aware, confident, competent and reflexive practitioners who are capable and can demonstrate self-direction and originality in tackling and solving problems and are able to act autonomously when assessing, analysing and evaluating complex and unpredictable human situations while also working in interprofessional contexts

Learners will demonstrate communication skills and develop the confidence to work as autonomous professionals actively promoting social justice and working in an anti-oppressive manner (T 1-5)

4. Entry Requirements

• The entry criteria for this programme is set by the Department for Education and applications are made via their portal. The selection process involves an initial short listing process by the DfE followed by a further shortlisting process by Local Authorities candidates have applied for. The assessment day consists of: 1. Written test 2. Group interview 3. Observed interaction with a People with Lived Exprience (role played by an actor) 4. Panel Interview The assessment criteria and assessment process are subject to change depending on Department for Education criteria.

If you do not meet the entry requirements you may, if you have relevant professional experience, still be invited for interview, where you will be required to demonstrate the necessary knowledge and understanding for entry onto the course.

Previous study, professional and / or vocational experiences may be recognised as the equivalent learning experience and permit exemption from studying certain modules in accordance with our <u>accreditation of prior learning</u> (APL) process.

Learning, Teaching and Assessment Learning and teaching

Taught sessions will be used to maximise students' prior experience and learning. A main theme of the teaching and learning is the integration of theory to practice. Lectures and seminars used to impart knowledge will be supported by workshops and more experiential methods where knowledge gained will be used to underpin practice experiences. The emphasis in the first part of the programme is on preparation for practice and the acquisition of an appreciation of the context in which social work operates including sociological, psychological and social policy context and introduces the legal context. Learners also begin to develop a critical ethical awareness of self as well as personal learning skills including participating in class discussions and listening to others with respect. During the first block of learning learners move from simple acceptance of professional values to a demonstrable commitment to them through their overt behaviour as well as resolving conflicts between competing values.

Learners are also expected to show a professional commitment to ethical practice daily. This is evidenced in their first practice learning placement which is in the first year of their studies where learners will have a placement within the partner local authority. The final block of learning builds on this foundation and introduces leadership and management and collaborative working. The final placement will enable learners to further develop their knowledge and skills in statutory legal interventions.

The acquisition and development of the required knowledge and skills laid down by the social work regulator, Social Work England, will be combined with the ability to transfer these elements to new practice situations. The transferability of skills forms the underlying rationale in this generic programme in relation to all areas of social work practice. The overall assessment strategy has been designed to complement learning in practice with learning within the University. Thus, academic modules are fully integrated with practice learning to consolidate learning on placement.

Teaching and learning sessions are conducted through a mix of workshops, discussion, experiential experiences, case-studies, simulations, group work, presentations, tutorials by external experts / internal specialists and guided independent study which are all inextricably linked with the practice experience. We are able to draw upon a wide range of practice placements to enable students to demonstrate competence and capability to Social Work England standards and meet all domains of the British Association of Social Work Professional Capabilities Framework.

Furthermore, the learning and teaching mechanisms by which the learning outcomes of the Step up to Social Work programme are achieved are designed to be consistent with the values of the profession for which the students are being prepared. Learners are encouraged to reflect and draw on their own experiences and to view tutors as facilitators to their learning which encourages students to become active in their own learning. The course blends academic and practice learning in an effort to integrate theory and practice. There is an emphasis on interaction, dialogue and debate and in this students are encouraged to make full use of our Virtual Learning Environment 'Blackboard', which is the main vehicle by which information is conveyed to students be it assessment guidance, update information, discussion boards and/or lectures notes. Practice Learning is an important part of the

programme and constitutes approximately half of the programme. More detailed information around Practice Learning is available in the Practice Handbook

Individual and group presentations

The design of assessments across the programme are such that they are inclusive and authentic. The assessment design recognises diversity in adult learning styles and the assignments aim to mirror tasks learners will be required to undertake in their employment. Assessment of all modules test whether the learning outcomes have been met.

Assessment of all modules will test whether the learning outcomes have been met. These ensure that the theoretical concepts are understood and can be related to practice. A variety of strategies are employed to test learning including portfolio, essay, presentations and time constrained assessments. Students will be required to research and evidence topics before applying it to practice. Preparation for practice learning and teaching will occur throughout the course in the dedicated skills development sessions within modules and also whilst on placement. This is supported by presentations, courtroom skills, and simulations where People with lived Experience and carers work with us to design and present realistic practice scenarios and the development of practice learning portfolios. There a number of formative assessment opportunities for students to receive feedback on their development before submitting summative work.

Readiness for Practice

Students will not be permitted to progress to the first Practice Learning Placement unless they have achieved a pass in the following modules:

Preparation for Intervention with People with Lived Experience - CW1 only

Due to the fast track nature of this programme there will be no reassessment opportunity for a students who fails Readiness for Practice.

Students must also have undergone an Occupational Health Assessment and achieved clearance, alongside satisfying DBS checks (an admissions requirement).

80% minimum attendance is required within the programme and is monitored in line with the Attendance and Engagement Policy.

Contact Hours

Learners can expect to receive approximately 312 hours of scheduled learning activities over the duration of the programme. A full breakdown of contact hours can be found in individual module descriptors.

Learners will also have two placement opportunities – 80 days in Block 1 plus 2 skills days and 110 days in Block 2 plus 3 skills days.

10 skills days will be delivered within the Preparation for Intervention with People with Lived Experience module.
